- 1. Submission Requirements: Each entry form must include:
- (a) A min. 1 minute working video showcasing the dog's abilities
- (b) Good quality photographs showing the dog from both sides
- (c) A detailed, accurate description of the dogs working ability, working history & temperament
- (d) (if applicable), registration certificate or pedigree papers.

Nomination forms, Photos & Video links must be submitted to auctions@trianglehorsesale.com by 9am Thursday 25th September 2025.

- **2. Demonstration of Skills:** All dogs must demonstrate their working capabilities with sheep or cattle and be of high quality. Triangle Sales has the final authority on the acceptance of entries.
- **3. Independent Work:** Dogs must show they can work independently in either a paddock or yard setting. Triangle Sales reserves the right to evaluate each dog's suitability for acceptance.
- **4. Video Quality:** The video must be high-quality and provided via a YouTube link, as it will be used to showcase the dog in an online catalogue.
- **5. Accuracy of Description:** All dogs must match the description on the entry form. Triangle Sales reserve the right to reject any dog that is uncontrollable, of inferior quality, or endangers stock.
- **6.** Age and Working Ability: Pups aged 4-10 months can be entered if they demonstrate working ability on stock alone, either in a paddock or yard setting. Videos must be supplied. The sale order will be dogs working cattle first, followed by young dogs and pups on sheep.
- **7. Description Verification:** If a dog does not match the entry form description, Triangle Sales may change its lot or remove it from the auction. No entry fees will be refunded for rejected dogs.
- **8. Biting Dogs:** Vendors who suspect their dog may be aggressive towards stock, other dogs or humans must state this in the catalogue. Dogs that bite sheep will need to be muzzled or withdrawn from the auction. No entry fees will be refunded for rejected dogs.
- **9. Sale Day Presence:** All dogs must be onsite on sale day and must participate in pre-sale demonstrations. Dogs being demonstrated must not be allowed to work in a fashion which may lead to stock being mistreated or injured. If so, the demonstration will be stopped immediately.

- **10. Non-substitution Policy:** Nominated dogs cannot be substituted or sold before the sale. Triangle Sales hold sole agency from the nomination through to 10 (ten) business days following the auction.
- **11. Entry Limit:** A maximum of 4 dogs per vendor will be accepted for the sale. Triangle Sales reserves the right to limit numbers.
- **12. Bitches in Oestrus:** No bitches in oestrus are allowed on the grounds. Entry fees will be refunded with a vet's certificate.
- **13. Condition Changes:** Triangle Sales reserve the right to alter these conditions to best suit public image or vendor needs.
- 14. Forfeiture Penalty: Forfeited dogs will incur an entry fee unless a vet certificate is provided.
- **15. Passed in Lots:** Triangle Sales exclusively hold the right to sell any lot from the nomination date until ten (10) business days after the sale. If a sale is referred, the referred buyer has one chance (first right of refusal) to buy the lot at the reserve price or a price agreed upon by the Vendor, Purchaser, and Auctioneer. If the sale isn't completed and the lot remains unsold, it can be sold to any registered bidder or through private negotiation chosen by the Auctioneer. If a lot is referred or not sold at auction and later sold to any party, the Auctioneer is entitled to 100% of the commission.
- **16. Goods & Service Tax:** if a Vendor is registered for GST, GST will be added to the knockdown price.
- **17. Handover:** All dogs must be handed over to the purchaser wearing a functional collar with the lot number attached. Lot numbers will be supplied on Auction Day.
- **18. Payment to Vendor:** Sale proceeds will be remitted to the Vendors nominated bank account details within ten (10) business days post sale.
- **19. Collection:** The seller agrees that if the lot is sold online or to a buyer from another state, they may need to hold the dog for a reasonable period while transportation is arranged.
